RESOLVED, that this resolution shall be the general appropriations for West Ottawa Public Schools for the fiscal year 2019-2020. A resolution to make appropriations, to provide for the expenditure of the appropriations, and to provide for the disposition of all income received by West Ottawa Public Schools.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriations in the GENERAL FUND for West Ottawa Public Schools fiscal year 2019-2020 is as follows:

BE IT FURTHER RESOLVED, that the West Ottawa Public Schools will levy **0.2909** mills against all property in the District for the purpose of generating revenue for Building and Site repair, construction, acquisition and improvement purposes.

BE IT FURTHER RESOLVED, that the Board of Education declares the millage rate of **7.75** mills be set against all property for debt levy for the 2019-2020 fiscal year.

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budgets adopted by the Board, and shall hold the building principals and department heads responsible for performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

BE IT FURTHER RESOLVED, that, for purposes of meeting emergency needs of the school district, transfers of appropriations may be made upon the written authorization of the Superintendent, but no other transfers shall be made without approval by the Board of Education. When the Superintendent makes a transfer of appropriations as permitted by this resolution, such transfer shall be presented to the Board of Education at its regularly scheduled meeting in the form of an appropriation amendment, which amendment shall be adopted by the Board of Education at such meeting. This appropriation resolution is to take effect on July 1, 2019.
