

## **BOARD OF EDUCATION**

**Regular Meeting** 

Approved Minutes September 21, 2020

A regular meeting of the Board of Education was called to order at 7:00 p.m. at West Ottawa Public Schools' Administration Office, 1138 136th Avenue.

President K. McCoy opened the meeting with the Pledge of Allegiance.

Moved by C. Lebster, supported by R. Schipper, to approve the minutes of the September 10, 2020, special work session as presented. Motion carried 7-0-0.

Superintendent Martin reported the following:

- <u>COVID-19</u>: The district has 92 student currently in quarantine, and 6 students confirmed positive for COVID-19. The health department calls any two or more cases that are connected an "outbreak." We continue to take all the precautions and do everything we can to mitigate COVID-19. We have not had any issues whatsoever with kids and masks. Kudos to the entire staff, kids and parents for complying with that Michigan Executive Order. In addition, the support of our Educational Association is great.
- <u>BOND UPDATE</u>: The office area is currently being worked on at Harbor Lights, and we continue with planning on athletics stadium, Performing Arts Center and Pine Creek Elementary School.

- They are hoping to reschedule homecoming events for a later date.
