### **Procedures for Purchasing Meals**

The West Ottawa Public Schools Food Service Department maintains accounts for each student enrolled within the district as well as students across the ISD that are serviced by the department. The accounts are identified by the student's personal identification number that he or she receives. This ID number remains with the student during their enrollment.

The most convenient and secure way for managing your child's lunch account is to visit <a href="http://westottawa.familyportal.cloud">http://westottawa.familyportal.cloud</a>, you will need to know your user id and password. This can be obtained by contacting the food service office at 616-786-2100. With Meal Magic Family Portal, you can deposit money into your child's lunch account using a debit or credit card. West Ottawa Public Schools is pleased to offer this service at no additional cost to you. The site also makes it easy to view your student's balance, monitor their daily purchases activity, and setup low balance e-mail alerts. Deposits made using https://westottawa.familyportal.cloud are typically available in your child's account within 5 minutes.

Payment for meals and deposits to lunch accounts can also be made using cash or check. Checks should be made payable to West Ottawa Public Schools. It is a good idea to include your child's name and the words "lunch money" in the memo section of the check. The most secure way to make cash or check payments is to visit our food service main office. Additionally, payment may be given to the building secretary or to the food service cashier during breakfast or lunch. A fee will be assessed for any returned checks.

## **Meal Pricing**

West Ottawa Public Schools has a tiered pricing structure based upon the age/grade of the student. For the 2024-2025 school-year, West Ottawa is participating in the Michigan School Meals Program and opted into CEP. Alternate agreement site and private school sites prices are as follows:

### Breakfast

• \$2.35 for all age/grade levels, \$.30 for reduced-priced qualifying students.

### Lunch

- South Olive Christian School and Corpus Christi Catholic School
  - o \$3.00 for full pay students, \$.40 for students who qualify for reduced priced meals.

# A La Cart Options

Milk, along with a wide variety of compliant snacks and beverages are available for additional purchase at our secondary schools (milk available at all buildings for additional purchase of \$.75). If you would like to restrict or prohibit your child from making additional purchases with their account, please contact the food service main office.

### **Qualifying for Free or Reduced Priced Meals**

The federal government provides financial assistance for households that meet certain size and income requirements. We encourage all families, regardless of income, to fill out the federal free and reduced priced meals application. A new application must be filled out for each school year. The application can be picked up in the main office of each building, the food service main office, or it can be filled out online at https://westottawa.familyportal.cloud. Applications can be submitted after July 1<sup>st</sup> for the upcoming school-year. During the 2024-2025 school year, CEP buildings families will complete the Student Benefit Form.

We strongly recommend filling out this application ahead of the start of the school year to ensure timely processing. Under federal law, ten business days are allowed for processing an application once it is received. The food service office makes every effort to process applications as quickly as possible; however, there is no guarantee an application will be processed the day it is received. Families are responsible for any meal charges that accrue during the processing period.

Once the application is processed, a letter will be sent by US or electronic mail notifying the family of their eligibility status. An application may be submitted at any time during the school-year if your family's income status changes. Additional information is available within the free and reduced priced meals application packet.

### **Charge Policy**

Charging for meals is strongly discouraged and places undue burden on the limited resources of the district in trying to collect money that is owed to the food service department for unpaid meal charges. That being said,

<sup>\*</sup>The aforementioned prices are only valid when the student selects a qualifying meal. Under the Healthy, Hunger-Free Kids Act of 2010, a qualifying meal must include 3 of the 5 offered food components. To simplify, the students must take one of the main entrée choices and at least a ½ cup of the fruit or vegetable that is offered.

the district does recognize that unforeseeable circumstances occur and understands the strong link between proper nutrition and excellence in the classroom. To ensure students are able to eat in emergency situations, the following charge policy is approved. The policy is based upon the notion that our students are being prepared to become college, career, and life ready, and should be taking on increased responsibility for themselves as they grow older.

# Alternate agreement sites not participating in Michigan School Meals Program

Students may charge up to the value of 3 lunches. For the 24-25 school-year, buildings not qualifying for free meals, this amounts to \$9.00 for a full pay student, and \$1.20 for a reduced-price eligible student.

In the event the student is unable to charge additional meals, an alternate meal will be provided to ensure a child does not go hungry. When the students charge limit is reached, and they have no remaining credit, they will be offered an alternate meal still meeting the minimum requirements of the National School Lunch Program. This meal is offered on the same 5 compartment tray as any other student. The meal is not to be discarded until after the meal service has been completed and there are no students or staff in the cafeteria serving area.

The following strategies are in place to minimize the number of students receiving alternate meals:

- The district uses https://westottawa.familyportal.cloud to facilitate adding money to lunch accounts. There is no additional fee to parents for using this service
- Food service cashiers are trained to notify students when their account balance is running low, and there is a need to deposit more money into the account. This is done in a private manner and not in front of other staff or students.
- Food service cashiers are trained to notify food service administrators if they observe a child receiving
  multiple alternate lunches. Food service administrators make every effort to contact families to get
  money added to accounts or to encourage families to fill out the free and reduced-price meals
  application.
- The Meal Charge Policy prohibits the following:
  - o prohibits the requiring of students who cannot pay for a school meal or who owe a negative balance to wear a wristband or handstamp
  - o prohibits the requiring of students who cannot pay for a school meal or who owe a negative balance to perform chores or other work to pay for school meals
  - o prohibits the requiring of students to dispose of a meal after it has been served because the student is unable to pay for the meal or has a negative balance
  - prohibits the direct communication with a student about a negative balance unless your district
    has unsuccessfully attempted to contact the student's parent or legal guardian first through
    telephone, mail, and electronic mail
  - o prohibits discussing a negative balance with a student in the presence of other students

## Menus

The build a meal feature makes it easy to calculate total nutrients, including carbohydrate counts, for the specific meal your child may eat.
