Statement
<p>The administration may consider providing pupil transportation service to and/or from a daycare/alternate site other than a student's official primary home address. To be considered, the student must first be eligible to receive pupil transportation service to their school of attendance from their official primary home address.</p>
Procedures
<p>Pupil transportation service to and/or from a daycare/alternate site <i>may</i> only be granted under specific conditions. A parent or guardian should carefully consider whether each of the following conditions can be met before applying online (see below) for pupil transportation service to the daycare/alternate site:</p> <ul style="list-style-type: none"> <li>• The requested daycare/alternate site is eligible for transportation to the same school of attendance as the student's official primary home address.</li> <li>• Service to the alternate address can be accommodated using an existing bus route servicing the school. (No new bus routes will be created to accommodate a daycare/alternate site.)</li> <li>• A student may be approved for only one (1) daycare/alternate site for morning and/or afternoon.</li> <li>• Pupil transportation service to and/or from the daycare/alternate site will only be provided when the request is for a consistent weekly basis, in the same manner for each school day of the week, in any combination of the following: <ul style="list-style-type: none"> <li>- All morning and afternoon service is provided from/to the daycare/alternate site; or,</li> <li>- Morning service from the daycare/alternate service address and all afternoon service to the official primary home address; or,</li> <li>- Morning service from the official primary home address and all afternoon service to the daycare/alternate service address; or,</li> <li>- Morning service from the daycare/alternate service address and no transportation (parent transport) in the afternoon; or,</li> <li>- No transportation (parent transport) in the morning and afternoon service to the daycare/alternate service address.</li> </ul> </li> <li>• A parent or guardian applies for use of an alternate address on an annual basis, on a timeline, and in accordance with procedures established by the Director of Transportation.</li> <li>• A parent or guardian carefully considers the capability and maturity of their child to manage the alternating schedule, given that the school will not guarantee boarding assistance on a daily basis and the bus driver is not responsible for managing alternating schedules.</li> <li>• A parent or guardian, and their student, accepts all responsibility for management of the alternating schedule, boarding the correct bus and disembarking at the correct assigned bus stop location.</li> </ul>

Requests for pupil transportation service to and/or from a daycare/alternate site should be submitted to the Transportation Department annually using the **Transportation Change Request Form** tab ([English](#)) / ([Español](#)) on the West Ottawa [Transportation Department website](#). Requests require a minimum of three (3) working days for processing. Approved requests expire at the end of the school year and must be resubmitted each new school year.
